- 1. that I am adopting the pet solely as a domestic pet for myself and/or my family. I will not use the animal for any illegal activity including fighting.
- 2. that I will not physically abuse, neglect starve or harm the pet in anyway.
- 3. that I will ensure the pet has adequate shelter.
- 4. that I will transfer the microchip into my name and keep chip details updated.
- 5. that I will keep up to date with all vaccinations. Vaccinations are annual unless otherwise specified.
- 6. to desex the pet if this has not yet been done.
- 7. To accept follow up calls from SWARS to obtain information on the pet (EG settling in, desex reminder, house inspection.)

I agree:

- 1. to a house inspection (physical or virtual) prior or within 2 weeks (14 days) after adoption.
- that the pet remains the property of SWARS during the 14 day in home trial and will remain so until SWARS and the adoptee are happy that the pet has adapted well to its new environment. (Full refund of any monies paid to SWARS for adoption will be made should trial fail within the 14-day period, or extended dates have been approved).
 - NOTE: If returned within the 14 day trial period an amount equaling 50% of payment will be refunded only
- 3. That if I am ever in a position where I can no longer keep the pet I will contact SWARS to have the pet rehomed at no cost to SWARS, before seeking other rehoming or abandonment options.
- 4. I understand that no guarantee is made regarding health or temperament of the pet and that the seller (foster carer) is not liable for any action taken by the pet. SWARS will help where they can for any health or socialisation but cannot offer any monetary value to these costs. Any costs incurred due to illness, injury or death while in the care of the adopter will be at the expense of the adopter.
- 5. I will pay the fee of \$_____in order to cover the cost of initial vaccinations, deworming, desexing, microchipping and pest prevention.

6.	That a deposit of \$will be paid upfront, and the remaining \$will be paid in weekly/fortnightly instalments of \$with the final payment being made on_//. (Any late payments may result in SWARS taking repossession of the pet).
